

Editorial BEGINNING THE FIFTH DECADE OF DEVELOPMENT

The "Journal of Civil Engineering and Management" has selected for coverage in Thomson Reuters products and custom information services. Beginning with Vol. 14(1) 2008, this publication will be indexed and abstracted in the following: Science Citation Index Expended (also known as SciSearch*), Journal Citation Report/ Science Edition.

I would like to congratulate the contributors, reviewers and members of the Editorial board of the journal with a high appraisal of their work and to thank them for a long-term collaboration. On this occasion, I would also like to make some observations and express my wishes for future development of the journal.

It turned 40 years in 2007 since it started to publish series of the studies in civil engineering in Lithuania. I would like to express my acknowledgement to Editors of this series: A. Čyras, A. Kudzys, G. Marčiukaitis, K. Antanavičius, Z. Kamaitis. During the period of 1967–1995 113 issues were published.

In Vilnius Gediminas Technical University the decision was made in 1995 to unite all these studies into a periodical journal. The research journal "Statyba" (Civil Engineering) was started to publish. Under this title 7 volumes were published, each of them consisted of 4–6 issues (Vol. 1–7, 1995–2001, print ISSN 1392-1525, online 1822-3605, Editor prof. E. K. Zavadskas). The papers were published in different languages.

Since 2002 the title of the journal was changed into "Journal of Civil Engineering and Management". During 2002–2008 volumes 8–14 were published. Each volume consisted of 4 issues.

During 1995–2008 the Journal has gained high popularity among Lithuanian scientists and many of their colleagues from abroad. Especially popular have become special issues (Martinaitis 2006) of the Journal, devoted to selection topics in civil engineering or containing papers, presented at international scientific conferences held in Lithuania (Zavadskas et al. 2004; Skibniewski et al. 2007; Zavadskas et al. 2008).

As previously, this Journal is published by Vilnius Gediminas Technical University in collaboration with the Lithuanian Academy of Sciences. It is internationally peer – reviewed and published in English with short abstracts in Lithuanian. The Journal aims to provide a multidisciplinary forum for researchers, designers, users and manufacturers involved in different fields of civil engineering and management.

- The topics included:
- building materials and structures,
- structural mechanics and physics,
- geotechnical engineering,
- road and bridge engineering,
- urban engineering and economy,
- construction technology, economy and management,
- information technology in construction,
- fire protection, thermoisolation and renovation of buildings,
- labour safety in construction.

"Journal of Civil Engineering and Management" is a refereed journal that publishes original research and review articles, as well as book reviews. It includes original articles presenting new information, case studies, major reviews and selected papers from the latest important conferences. These publications provide essential ideas and information that will help for new scientific inquires and improve competency, efficiency and productivity of world markets.

From vol. 14(3) "Journal of Civil Engineering and Management" is encouraged by International Council for Research and Innovation in Building and Construction (CIB).

In its editorial board there are also working the President of the UN-established CIB prof. Peter Barrett and IAARC president – Prof. Ronie Navon. The Editorial Board of the journal consists of 33 professors from abroad representing 19 countries. For journal's publishing also actively worked the Local Editorial Board made of Lithuanian scientists from civil engineering. These scientists accomplished the primary reviewing of the received papers. If the paper is not rejected during reviewing, it is sent at last to the foreign reviewers (see Table in Zavadskas 2008). Since 2006, "Journal of Civil Engineering and Management" has North American Editor Prof. M. J. Skibniewski.

The annual number of articles published in 2002–2008 is reflected in Fig. 1 and number of cites in Fig. 2, 3 and Table 1.
